Dear Providers,

Summer is almost over and Kids are going back to school. This year that means remote learning for a lot of children. Our first note of the month covers how to claim school aged kids if they are also doing remote learning while in your care:

1) Claiming School Aged Kids who are Remote Learning:

A) If students enrolled at a nearby school are participating in remote learning at a child care facility offering CACFP meal service, would the meals served at that facility be claimed by the child care facility or the school?

The meal may be claimed by either the child care facility or the school, depending on the agreement, if any, between the two sites as well as the limitations imposed by licensing requirements. Available options include the following: If a student is paying enrollment fees to the facility while participating in remote learning and is eligible for CACFP meals, the child care facility may claim those meals in accordance with all CACFP regulations and eligibility guidelines. No agreement is required with the school. NOTE: Child Care Homes must abide by all licensing requirements to be approved as a CACFP site. For example, if the licensing information submitted to TDA stipulates that the age of enrolled children must not exceed 12, and the site application now indicates that children 13 or over are now enrolled, TDA will not approve that application

B) What should a Provider do if they are claiming a School Aged Kid who is participating in Remote Learning for Am Snack or

Lunch?

Normally when a provider claims School Aged kids outside of Summer Vacation they are required to mark an excuse in order for the meals not to be disallowed. Since there is no Covid-19 or Remote Learning excuse under Enter Meal in KidKare you will need to choose "School Holiday" or "No School" and then write "Covid-19" or "Remote Learning" in the comment box at the bottom of the screen. 2) Re-enrollment is being sent out Next Month!

Its that time of the year. Training is due and Re-Enrollment is right around the corner. We will be mailing your Enrollment Renewal Packets at the end of September. Please withdraw any kids you don't plan on re-enrolling so they don't show up on your packets! The packets are due November 3rd! Please DO NOT send your re-enrollment ahead of time. Wait until your receive the packet and then submit it.
